## **West Patton Village 2022-2023 Infrastructure Project:**

Deep Apologies for the water outage on 1/13/2023. This was not a planned outage. WPV project being a complete Infrastructure rehab, unexpected things may happen. This was not planned or expected. A water line gave way during construction and contractors and HPUD staff resolved the issue as quickly as possible. With 70+ year old pipes, some areas maybe more fragile than others. Please be assured that the contractors and staff are making every effort possible not to disrupt your service.

**FACTS:** Project estimated cost \$13,426,600.00. Water is all SRF Grant and Sewer is a combination of both grant and loan.

-County and HPUD has a 7 foot easement from the sidewalk into each yard.

-Whatever is torn-up during constructions will be replaced as good or better by completion of project.

-Current easement forms will need to be filled out by all residence in Hillcrest and Mt. View .

-Please check your newsletter each month for updates

-Updates will be available on HPUD website

-Contractors will notify you when they will be working on your street, 24 to 72 hours ahead of time.

. HPUD staff and Contractor will be notifying you as progress moves forward!
