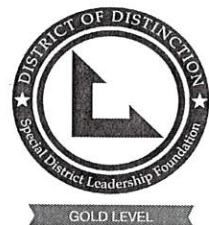

## West Patton Village 2022-2023 Infrastructure Project:

The Contractors have completed main line sewer on 5/17. Construction began on the main water line on 5/16/2023 and should be complete this week 6/23. A Second crew will continue working on individual residents connections to the new system. Contractors will be hanging temporary shut off notice the night before they make the new connections to your home. The week of 6/19, they will also be working in Hillcrest and Mt. View installing meters and lateral lines to front of homes. Guess Plumbing will be back out the week of 7/10 to make the actual connections for those homes again in Hillcrest and Mt. View only. The first part of August, Q & D Construction will be tearing up the roads and preparing to replace roads and driveway aprons. Road construction will last 60 to 90 days, than we will have new streets! Please drive slowly through the neighborhood for the safety of the contractors, children and yourself. Construction will continue all summer, so please be patience and considerate to one another. Completion estimated 9/29/2023.

**FACTS:** Project estimated cost \$13,426,600.00. Water and Sewer is SRF (State Revolving Fund) Grant.

-County and HPUD has a 7 foot easement from the sidewalk into each yard.

-Whatever is torn-up during constructions will be replaced as good or better by completion of project.

- Rate Changes will occur, as contractors complete portions of their work.

The Community approved rate changes for this project and the State Funding with Resolution 2019-03 and Resolution 2019-04 on September 17, 2019.
